Foreword

Welcome to the *BEESPEED* J.J. Brown Memorial Road Rally 7th-8th January 2023.

The *BEESPEED* J.J. Brown Memorial Rally may be held under any Covid-19 guidelines issued by the Welsh Government and Motorsport UK that apply on the date of the event. All entries must be made online. Signing-on for competitors and marshals will be carried out electronically.

Building on the previous years, we will provide a balanced event, providing a suitable challenge for the more experienced crews whilst keeping a simple, “no-nonsense” format to encourage novices to participate. The entry fee will include an evening meal and breakfast for each driver and navigator and the required map will be supplied by the organisers with the full route including all controls to each competitor.

The event is open to a maximum of seventy-five cars. **Every crew must supply a marshalling crew**, who must be signed on before their competing crew may be confirmed to start. Named rally officials may not be nominated as marshals.

Competitors must have valid membership cards of one of the listed clubs and must hold a 2023 Motorsport UK competition licence of Clubman RS status or higher. You will be required to sign on online (see SR6) and upload photos of club membership cards and competition licences. Marshals will also need to sign on online.

IMPORTANTLY – The third-party insurance cover is now with **Bluefin Sport** and we will email each competitor wishing to use the scheme a Driver Declaration Form, which must be completed and returned to us stating they can either comply or not comply with the Declaration. For those that do not comply, we will forward the form to Bluefin Sport for a Letter of Acceptance to be issued.

SUPPLEMENTARY REGULATIONS

1 ANNOUNCEMENT

The Caernarvonshire & Anglesey Motor Club Ltd will organise a Clubman Status Road Rally on Saturday 7th and Sunday 8th of January 2023, known as the *BEESPEED* J.J. Brown Memorial Rally.

2 JURISDICTION

The meeting will be held under the General Regulations of the Motorsport UK. (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations and any written instructions that the organising club may issue for the event.

3 AUTHORISATION

Motorsport UK Permit number 128619 has been issued.

DoE authorisation has been applied for and will be displayed at the start venue.

4 ELIGIBILITY

The event is open to fully elected members of Caernarvonshire & Anglesey Motor Club, 116 Car Club, Bala & District Motor Club, Broughton & Bretton Motor Club, Clwyd Vale Motor Club, Harlech & District Motor Club, North Wales Car Club, and the Rhyl & District Motor Club
All competitors must hold a valid RS Clubman Licence issued by Motorsport UK.

All competitors must hold a current club membership card.

All drivers will be required to declare that their vehicle is taxed and insured for the road and has a current MoT certificate (if applicable).

It is compulsory that all competitors respect the regulations for Control of Drugs and Alcohol as contained in the General Regulations C1.1.7, D25.1.14, D35.1, G15.1.4, H38 and have also fully familiarised themselves with the information on the web sites referred to (www.motorsportuk.org, www.ukad.org.uk and www.wada-ama.org) the UK Anti-Doping Rules which have been adopted by Motorsport UK. Further, signing as the parent or Guardian of a minor it will be deemed consent is given to the testing of that minor (UK Anti-Doping Rule 5.7.2)

5 CHAMPIONSHIPS

The events qualify for the Glynne Edwards Memorial Championship 2023 and relevant Caernarvonshire & Anglesey Motor Club championships.

6 PROGRAMME

The event will start and finish at Plas Menai National Outdoor Centre, Y Felinheli, LL55 1UE; Map Reference 115/503 660.

Signing on should be done online via the link in the entries system, using the password created when completing the entry form.

NOTE: This link will be open from 20.00 hours on Sunday, 4th December 2022 and close at 22.00 hours on Wednesday, 4th January 2023. You will be required to upload photos of your valid club membership card and Motorsport UK Competition Licence (minimum grade RS Clubman).

Noise check and Scrutineering will take place between 17:00 hours and 20:45 hours at a location to be notified in the Final Instructions.

Any crew (including their marshal) not signed on by 21:00 hours may be refused a start and their place offered to a reserve crew. There will be no refund of entry fee.

No maps will be required as by the competitors as a marked map will be provided by the organisers. Your marshal will require Ordnance Survey map 115, 1:50,000 scale

Cars will start at one-minute intervals and the time of issue of route information will be advised in the Final Instructions. Car 0 will finish at approximately 04:15 hours. Competing cars are required to carry enough fuel to cover 60 miles. Total mileage will be approximately 105 miles.

7 SCRUTINEERING

Scrutineering will be in compliance with the Road Traffic Act. General Regulations Section J and R18 – 20.1.14. Cars will also be required to undergo a noise test. If over 86dBa is registered at 2/3 max rpm at 2 metres distance on the noise meter, they will not be permitted to start (J5 .18.1 – 5.18.11, R4.1 – 4.1.3, R8.5 – 8.5.2). Noise checks may also be performed on route at the discretion of the organisers. Crews failing either noise test or scrutineering will not be permitted to start and will not be refunded their entry fee.

All competitors must bring their car to scrutineering and noise. Non-competitors cannot bring the car to scrutineering under any circumstances. Penalty **EXCLUSION**.

Close attention will be paid to the following at scrutineering:-

- Body Damage
- **CATALYTIC CONVERTERS HAVE TO BE INSTALLED ON ALL CARS MANUFACTURED AFTER 1/1/2000**
- Tyres must be legal at all times and comply with R18.4 – 18.4.3. As per L.3.2 (A, B & C). The cutting of tyres is not permitted. **Only “E” marked tyres are permitted.**
- **SPECIAL NOTES ON TYRES:** Breach of R 18.4.1 will result in exclusion.
- No loose items within the vehicle.
- Throttle linkage must be in good order and to specification.
- A maximum of two spare wheels must be securely located.
- A red reflective Warning Triangle must be carried.
- A first aid kit must be carried.
- Road fund licence. It is the driver's / owner's responsibility to ensure the vehicle VEL is valid for the event.
- The original test centre MOT certificate must be produced.
- Vehicle Registration Document must be produced.
- If a vehicle is hired or borrowed a letter of consent from the owner must be supplied.
- Bodywork and paintwork must be in good serviceable order.
- Air filters must be fitted.
- No radio transmitting devices are permitted except that in the interest of safety.
- Mobile Phones may be carried but must remain switched OFF during the event.
- All vehicles must carry a small spill kit complying with J5.20.13 (R46.1.5)

!! Tyres – All tyres Must be “E” marked without exception !!

All tyres used on the Public Highway must comply with the relevant Motor Vehicle Construction and use regulations.

At all times during the event all tyres must be road legal.

Requirements are specified in R 18.4. (Road Rallies).

8 CLASSES

The following definitions apply to either crew member in the role now entered (driver as driver / navigator as navigator) based on their previous performances, ***no matter how long ago***, as follows:

CLASS 1: MASTERS

Either crew member having won any Interclub or National B Road Rally at any time.

CLASS 2: EXPERT

Either crew member having finished in the top 10 on any Interclub or National B or Clubmans Road Rally (except for Novice event), or higher status rally at any time.

CLASS 3: SEMI-EXPERT

Crews not classified as Masters, Experts or Novices.

CLASS 4: NOVICE

Neither crew member having won no more than one class award on any Road Rally (i.e. 1st, 2nd or 3rd in class) at any time.

If fewer than 5 cars are entered in any one class, this class may be amalgamated with the next appropriate class.

9 ENTRIES

The acceptance of entries will open 20.00 hours on Sunday 4th December 2022, and close at 18:00 hours on Monday 2nd of January 2023.

The maximum number of entries is 75 and the minimum is 40

The entry fee is £120, which includes **two evening meals, two breakfasts and the appropriate map**. All entries will be acknowledged and given a reference number.

Entries cancelled before the closing date will be refunded, less £10 to cover administrative costs. **Entries cancelled after the closing date will not be refunded.**

Should the entry list fill, a reserve list of up to 10 cars will open. Reserves will be kept advised of their position on the list. Reserves who sign-on, but are not offered a run, or choose not to run, will be refunded in full.

In the event of an unforeseen incident causing the cancellation of the event, the organisers reserve the right to retain a non-profitable amount of entry fees to cover event costs.

Entries must be made by completing the online entry form.

The entry form must be completed in full and accompanied by the appropriate fee. Payment by PayPal will not be subject to any surcharge.

Entries will be acknowledged as recorded online, but the entry will not be fully accepted until the correct fee has been received.

It is a condition of entry that every competitor must supply a marshal that is **not a named official** and their details must be given on the entry form. A marshalling crew nominated by a competing crew cannot represent a second competing crew.

NO MARSHAL = NO START

All communication will be made by email to the driver or navigator as nominated on the entry form. Please ensure your e-mail address is accurate and very clear.

Entries will be accepted at the organiser's discretion.

10 INSURANCE

Bluefin Sport

The organisers have applied to Bluefin Sport for a Blanket Cover Note under the above scheme. This will provide competitors who need to use the scheme with the Third Party Cover necessary to meet Road Traffic Act requirements on the road sections of the event.

If you have extended your own private Motor Insurance to cover the event the following does not apply. However, all drivers must complete a Declaration form (see below).

The basic rate for the event before any loadings will be **£27.50**. All applicants wishing to use the scheme must be able to comply with all points of the following Bluefin Sport Declaration: -

- I do not have the Third-Party Road Section extension on my current Motor Insurance.
- I am aged 19 or over.
- I have had no more than 1 fault claim in the last three years.
- I have no more than a maximum of 6 conviction points or a licence ban on my UK driving licence.
- I have the appropriate competition licence as well as a UK/EU driving licence and if my licence is provisional, I will be supervised by an adult over 25.
- I have no physical or mental disabilities.
- My vehicle is MOT'd, Taxed and Insured for the road.
- I have no other material facts to disclose.
- Anyone aged less than 19 years old will also be accepted at the same price should their co-driver be a more senior member of their family or over 25.

Each competitor will be emailed a Driver Declaration Form, which must be completed and returned to us stating they can either comply or not comply with the Declaration. This applies to **ALL** drivers, whether they intend to use the scheme or not.

For those that do not comply with the above declarations, we will forward the form to Bluefin Sport for a Letter of Acceptance to be issued.

12 TYPES OF SECTION:

The event will contain the following types of sections:

STANDARD R.10.2: These sections are used to test navigation. And can be timed to the previous whole minute or previous whole second.

NEUTRAL R.10.3: These are sections used to take competitors through PR-sensitive areas. They will be driven with as little noise as possible, without the use of auxiliary lamps except in conditions of fog or falling snow. There are no lateness penalties, except towards OTL.

13 CONTROLS / TIMING

A number of controls will be timed to an accuracy of less than 1 minute; competitors are reminded of R 12.5.1.

Examples of each type of board to be used will be on display in the signing-on room at the start. Controls must be visited in the order on the Time Card. Competitors may reduce lateness and are reminded of R12.6.1.

Should an entry on a Timecard not be legible, or not appear to be authentic it may be considered not to have been made. Organizers may refer to Marshals Check-sheets in case of doubt. Any alterations or amendments to Timecards will only be accepted if countersigned by the marshal at time of amendment. **It is the competitor's responsibility to ensure that his/her timecard is correctly marked.** It is not the duty of the marshal to neither interpret these regulations, Motorsport UK regulations, or any other written instruction given to the competitors, nor explain the meaning thereof.

Main Time Control: - Located throughout the event and their location is given. The marshal will record his/her signature, direction of approach and the time showing on the clock **when the competitor's timecard is presented**, in hours and minutes. You must visit these controls within your Maximum Lateness to be classified as a finisher.

Standard Time Control: - These timed controls are located at the end of a Standard Section and their location is given in advance. The marshal will record his/her signature, direction of approach and the time showing on the clock **when the competitor's time card is presented**, in hours, minutes and sometimes seconds.

Neutral Time Control: - These timed controls are located at the end of a Neutral Section and their location is given in advance. The marshal will record his/her signature, direction of approach and the time showing on the clock **when the competitor's time card is presented**, in hours and minutes.

Passage Control (PC): - Un-timed manned control to prove adherence to the correct route. The competitor must stop and present the Time Card for the marshal who will enter his/her name and direction of approach. They may be replaced by a Route Check (RC) with no prior notice.

Route Checks (RC): - This unmanned PC will be identified by a **CODE BOARD** at the road side, containing a number of letters and/or numbers which must be noted by the competitor **IN INK** onto the Time Card, and **signed for by the marshal at the next manned control** to prove adherence to correct route.

Secret Checks (DSO): - Manned by a Driving Standards Observer, location will not be given. All competitors must stop and hand over their DSO / Damage card to the observer. Secret Checks will be established to ensure compliance with the Regulations, in particular the following under R9.1.3. Give Ways. Competitors will be required to stop at all junctions specified as "Stop" and "Give Way" junctions on the route cards. At these junctions all four wheels must be seen to stop and all forward motion must cease before the Give way line or entering any road.

Judges of Fact (see G10) and Driving Standards Observers (see G11) will be appointed to adjudicate on:

Failure to stop at Stop or Give Way junctions.	False starts from any Time Control.
Compliance with Quiet Zones.	Unauthorised servicing.
Not complying with the route card.	Violation of out of bounds areas.
Driving in a manner likely to bring motor sport into disrepute.	Excessive sound.

Caernarvonshire & Anglesey Motor Club is increasingly concerned at the driving behavior of some competitors at manned controls. Arriving at a control at a high speed with locked brakes can put the marshal at great risk. If the competitor car also has headlight main beam and spotlight(s) illuminated, this increases the risk as it impairs the vision of the marshal. We feel that we need to take action to ensure the safety of marshals.

R.9.2.1. - Any control is considered to extend for 50m around the actual point at which Officials are making their records, unless clearly visible signs are displayed to define a different area.

Driving Standards Observers will be present at controls to ensure that the following procedures are adhered to.

1. Competitors must dip light and extinguish spots at the 50m board.
2. Reduce speed so that you can stop at the marshal's location without locking your wheels.
3. Leave the marshal's location only when the marshal is clear of the car.

Failure to comply with these instructions will result in penalties being applied as per R8.4

14 QUIET ZONES

Along the route the organisers may establish Quiet Zones by notification in the route cards. Additionally, the use of Quiet Boards followed by OK boards will be placed to aid crews. They will be driven with as little noise as possible, without the use of auxiliary lamps except in conditions of fog or falling snow.

15 BLACK-SPOTS

Certain areas may be classified as Black-Spots. Competitors must not enter these areas for any reason, even upon retirement as they are P.R. sensitive areas. The penalty for infringement is disqualification.

16 PENALTIES

Penalties will be assessed as per R.13, but modified as follows:

CONTROLS SITED AT THE END OF A NEUTRAL SECTION

- a. Early Arrival 1 Fail.
- b. Late Arrival No penalty, other than maximum lateness.

CONTROLS SITED ON A STANDARD SECTION

- a. Early arrival (start of section) 1 Fail per minute or part of.
- b. Early arrival (end of section) 1 Fail per minute or part of (ignoring seconds carried forward on sections timed to the minute).
- c. Late arrival at end of section:
 - 1 second per second (Timed to the second section).
 - 1 minute per minute (Timed to the minute section).

OTHER PENALTIES

- a. Not reporting or reporting OTL at a main control (MC) Retirement.
- b. Not complying with the route card including visiting a control twice 1 Fail per offence.
- c. Not providing proof of visiting a passage control (PC) 1 Fail.
- d. Not obtaining a signature from DSO or Secret Check 1 Fail.
- e. Not providing proof of visiting a Route Check (RC) 1 Fail.
- d. Breach of statutory requirements concerning use of a motor vehicle..... Disqualification.
- e. Excessive driving in a manner likely to bring the sport into disrepute..... Disqualification.
- f. Excessive noise Disqualification.
- g. Receiving assistance contrary to 7.2.4 Disqualification.
- h. Breach of 7.2.3, 18.6.4 Disqualification.
- i. Breach of 5.4, 9.1.3, 9.1.4, 9.1.5, 9.1.6c., 15.1.2, 15.1.4. Disqualification.
- j. Using a mobile phone to acquire route/control information that the crew would otherwise not possess Disqualification.
- k. Defacing or altering a timecard Disqualification.

- l. Breach of "It is compulsory that all competitors respect the regulations for Control of Drugs and Alcohol as contained in the General Regulations C1.1.7, D25.1.14, D35.1, G15.1.4, H38 Disqualification.

Additionally:

Any competitors found to be utilising mobile phones to acquire route/control information that they otherwise would not possess or to find their location will be disqualified.

17 DAMAGE

Damage checks to competing cars will be made at the start, during the event and at the end. All competitors will be required to complete a damage declaration form to be handed in at the finish or, in the case of retirement, forwarded to the Entries Secretary within 72 hours. Failure to do so will result in a competitor being reported to Motorsport UK and Club committee.

Competitors are reminded that the submission of a damage declaration form does not in itself negate their responsibilities within the law if they have been involved in a Road Traffic Collision. Any injury/damage to third parties **MUST** be reported to the Police and event organisers immediately so they may arrange prompt action / repairs.

R 15.1.4 - Vehicle damage in relation to 13(q) will be considered as being any tear or indentation exceeding 50mm in depth occurring to the external surfaces of the coachwork or its accessories (excluding windscreens, windows, lamps, and bumpers) above the horizontal plane at the wheel center.

18 RESULTS

Assessment of performances between crews will favour the crews with the fewest number of 'Fails'. Ties will favour the crew that incurs the lesser total time penalties, and so on. Further ties will favour the crew who incur the lesser time penalty first.

Enter online at www.camconline.co.uk

To be classified as a finisher a competitor must visit all Main Controls, noise checks and scrutineering ('Damage') within OTL in the same car that they started the event and avoid the penalty of disqualification. Provisional results will be published as soon as possible after the last car has arrived at the finish venue. Protests must be made in accordance with Motorsport UK regulation C 5

Results may be declared final 30 minutes after being declared provisional at the finish. No discussions will be entered into regarding your or any other individual's results after they have been declared Final. Failure to comply may result in the crew being reported to motorsport UK. Please remain at the finish venue until the results are final.

19 AWARDS

Awards will be presented at the finish venue once results are declared final. The named trophies and cups remain the property of Caernarvonshire & Anglesey Motor Club Limited and must be returned within one year, or upon request, whichever is earlier.

1 st Overall	A trophy and awards to driver and navigator.
1 st in each class	Awards to driver and navigator.
2 nd in each class	Awards to driver and navigator
3 rd in each class	Awards to driver and navigator (subject to a minimum of 10 entries in the class).

Should there be less than five entries received in any class, the organisers reserve the right to amalgamate that class with the next appropriate class (see section 6 above).

20 MARSHALS

Due to the format of the event a large number of experienced marshals will be required. It is a condition of entry that **every competitor must supply a marshal** that is **not a named official** and their details must be given on the entry form. Marshals will be required to sign on online.

A marshalling crew nominated by a competing crew cannot represent a second competing crew

If your marshalling crew have a preference as to what type of control they would like to marshal, then please inform the Chief Marshal as soon as possible. Marshals are required to wear 'Hi-Viz' fluorescent and reflective jackets or tabards at controls. OS Map 115 is also required.

21 PRACTISING

From the date of the submission of an entry, any crew judged by a named official and considered to be practising and/or driving in a manner likely to bring motorsport into disrepute will be reported to the appropriate authorities and entry to this event refused with no refund of entry fee.

22 FINAL INSTRUCTIONS

Final Instructions will be and published at www.camconline.co.uk and sent by email in the week prior to the event to the person nominated on the entry form at the time of entry. Please ensure you provide a correct email address.

23 MISCELLANEOUS

Any amendment displayed en-route bearing the signature of one of Joint Clerk of the Course, Secretary of the Meeting, or the Chief Marshal, shall have the same authority as these SRs.

The official notice board will be at the Start and Finish venue and every competitor will be deemed to have read all such notices.

All organisers' times =and mileages are deemed correct.

The route has been plotted using a basic romer (1:50,000).

Servicing is not permitted. A car may only be worked on by its crew, using only tools and spares carried in the vehicle from the start of the event.

The only tyres permitted are those fitted to the car and carried as spares in the car when presented at scrutineering.

Competitors will be identified by two rally plates supplied by the organisers, and these must be fixed to the near side window and the rear of the vehicle as per R6.1.1. These must be removed immediately upon completion of the event or upon Retirement /Disqualification R6.1 – it is the competitor's responsibility to ensure plates are legible throughout the event.

The nearest A&E hospital is Ysbyty Gwynedd (557/702) 01248 384383 (999 in an emergency).

24 DATA PROTECTION

In relation to your entry to our event, we collect and hold certain personal data that you have provided on your entry and signing-on forms. Personal data includes any data that relates to an individual and can be linked to them, such as name, address, phone number(s) and email address. Under the General Protection Regulation (GDPR) we are required to have your consent to Caernarvonshire & Anglesey Motor Club Ltd holding such data, which will be used by us in connection with the event you have entered to enable us to administer the event and as required by Motorsport UK regulations. We might use your information to send you marketing messages by email about forthcoming events, but not if you have indicated on the entry form that you do not wish us to do this

The Club will be the data controller for the purpose of the GDPR and the Data Protection Act 2018.
