The minimum age for a PCA driver is 14 years and a PCA passenger, 12 years old. If the driver does not hold a full driving licence, they must carry a passenger who holds a valid licence and be experienced in Autotests or Autosolos.

SUPPLEMENTARY REGULATIONS

1. ANNOUNCEMENT

The Caernarvonshire & Anglesey Motor Club Ltd will organise a Clubmans Production Car Autotest (PCA) on Saturday, 27th December 2025 at Trac Môn/Anglesey Circuit, Ynys Môn (Anglesey) LL63 5TF; OS map reference 114/333 688½. what3words - ///props.toads.pile

2. JURISDICTION

The meeting will be governed by the General Regulations of Motorsport UK Ltd (incorporating the provisions of the International Sporting Code of the FIA) these supplementary regulations and any written instructions the organising club may issue for the event.

3. PERMIT

Motorsport UK permit number 205356 has been issued.

4. ELIGIBILITY

The event is open to members of 116 Car Club, Bala & District MC, Broughton & Bretton MC, Caernarvonshire & Anglesey MC, Clwyd Vale MC, Harlech & District MC, Knutsford & District MC, North Wales Car Club, Rhyl & District MC and Under 17 Motor Club North-West.

All competitors will require a valid 2025 Motorsport UK competition licence of Clubman RS status or higher and a valid club membership card.

You may renew or apply for C&A Motor Club membership online at https://www.camconline.co.uk/become-a-member.

Drivers who do not hold a full, valid RTA licence may enter provided their navigator holds a full, valid RTA licence.

Minimum age of a PCA driver is 14 years and PCA passenger is 12.

For a driver who does not hold a valid, full RTA licence, the vehicle must by definition be a 'Touring Car'; the vehicle engine capacity must not exceed 2000cc including forced induction; also, a passenger must be carried who holds a valid RTA licence and be experienced in Autotests or Autosolos.

5. CHAMPIONSHIPS

The event qualifies for the 2025 C&A Motor Club championships.

6. PROGRAMME

Signing-on and Scrutineering opens 08:00 hours at the Circuit cafe.

Signing-on and Scrutineering closes 09.00 hours.

Any competitor not signed-on by 09:00 hours may be classed as a non-starter.

There will be a drivers' briefing at 09:45 hours, after signing-on.

First car starts at approximately 10:00 hours.

There will be a lunch break, and the finish is expected to be at approximately 15:00 hours.

There will be refreshments and toilets on site.

7. CLASSES

The event will consist of two classes as follows:

A - Front-Wheel-Drive (FWD).

B – Rear-Wheel-Drive (RWD).

Technical:

Tyres must have a minimum tread depth of 1.6 mm at the start of the event.

Cars must not be fitted with tyres from lists 1B or 1C of the National Competition Rules – **NCR 8.4**.

Cars must not be fitted with M&S / Mud & Snow / Gravel Tyres.

All cars must comply with relevant regulations from Chapter 7 of Motorsport UK's National Competition Rules.

Competing cars do not need valid MOT or Tax, as the whole event takes place on private property.

Passengers must wear seatbelts and keep arms and hands inside the car when seated. Cars must have the original bumpers and lamps at the front and rear.

8. ENTRIES

Entries will open on publication of these Supplementary Regulations and close at 09.00 hours on Saturday 27th December 2025.

The maximum number of entries for the meeting is 40. The minimum is 15.

Entries will be accepted at the organisers' discretion, using a first come, first served basis. A car may only be shared by a maximum of two drivers; they will be taken as two separate entries.

The entry fee is £40, or a reduced entry fee of £25 for each driver under 18 years of age on the day of the event.

All entries should be submitted via the online entry form link at www.camconline.co.uk and accompanied by the correct fee.

Entry fees may be refunded for entries withdrawn before entries close.

Entries withdrawn after entries close will have refunds made at the discretion of the club. In the event that the event is abandoned or postponed, entry fees will be refunded in full.

All marshals are Judges of Fact with regard to test penalties and their decision will be final. A list will be available for examination at the event.

10. TESTS

The number of tests will depend on the number of entries at the discretion of the Clerk of the Course. Competitors will be kept advised during the day.

Timing will be by stopwatch.

The starting procedure will be:

Place front wheels on the first start line.

Start when ready after the timekeeper instructs you to "Start in your own time". Timing will commence when the front wheels cross the start line.

The finish procedure will be:

Timing stops when the front wheels cross the finish line. Competitors must "stop astride the finish line". Failure to stop astride the finish line will result in a line penalty being applied.

The order of attempting tests will be at the organisers' discretion.

11. PENALTIES

*For (a), (b), (g) & (l), the maximum penalty shall be the fastest time (including penalties) taken on that test plus 50%. (E.g., fastest time by anyone being 60 seconds would result in a maximum time for others of 90 seconds - 60+30=90).	

12. FINAL INSTRUCTIONS

Final instructions will be available at www,camconline.co.uk

13. RESULTS

Results will be published at the venue as soon as possible at the end of the event. Any protest must be in accordance with Motorsport UK regulations. To be classified as a finisher the driver/crew must attempt at least 50% of the tests in the car in which they started.

14. AWARDS

Awards will be presented at the conclusion of the event to the overall and class winners. Second and third in class awards may be presented subject to three and eight entries respectively in the class. There will also be an award for highest placed lady driver.

15. PRACTICING

Practicing anywhere in or near the venue is prohibited and shall be penalised by disqualification. This will include speeding, handbrake turns, skidding, wheel spinning and aggressive driving whilst not on tests.

16. IDENTIFICATION

The competition number must be displayed clearly in the top passenger side corner of the screen, or visible from the front if the screen is not large enough.

Drivers will be seeded by ballot within classes, with the organisers taking any dual entries into consideration.

17. MISCELLANEOUS

All other National Competition Rules of Motorsport UK apply as written, except for the following, which are amended:

NCR 19.3.1.2 - Vehicles need not be taxed and registered for the road as the whole event takes place on private property.

NCR 19.1.1.4k - A car may be shared by a maximum of two drivers, but no driver may drive more than one vehicle.

NCR 19.1.2.7 - Pylons may be less than 1m in height.

NCR 19.1.3.11 - The definition of test performance and wrong test will be used as follows:

In any diagram illustrating a test, dimensions will be approximate and for guidance only, whilst a sequence of manoeuvres will be mandatory but not exclusive. A maximum penalty will be imposed when the mandatory sequence of manoeuvres has not been completed. A test will not be incorrect if the driver realises his/her mistake, goes back to the point at which the mistake occurred and then completes the test correctly as required by the diagram.

18. DAMAGE

If a competitor causes third party damage during the event, they may be liable to the repair costs up to the value of the insurance excess (currently £500).

18. DATA PROTECTION

In relation to your entry to our event, we collect and hold certain personal data that you have provided on your entry and signing-on forms. Personal data includes any data that relates to an individual and can be linked to them, such as name, address, phone number(s) and email address.

Under the General Data Protection Regulation (GDPR) we are required to have your consent to Caernarvonshire & Anglesey Motor Club Ltd holding such data, which will be used by us in connection with the event you have entered to enable us to administer the event and as required by Motorsport UK regulations. We might use your information to send you marketing messages by email about forthcoming events, but not if you have indicated on the entry form that you do not wish us to do this.

The Club will be the data controller for the purpose of the GDPR and the Data Protection Act 2018.
